This letter is to inform our valued customers that service and support for the above listed units will be discontinued effective September 9, 2020. After this date, VIAVI Solutions, formerly Aeroflex, and our 3rd party service providers (refer to list on page 2) will no longer accept RMAs for repair or calibration work for these products and will no longer carry or stock components or sub-assemblies. Effective October 9, 2020, VIAVI and our 3rd party service providers will no longer accept deliveries of these products.

Some of these products have been in use for more than 40 years and are part of the IFR legacy products. We have successfully supported them over this period due to our technical abilities and because of the passion we have for these products. The decision to discontinue support was not made lightly but as these units age, parts obsolescence and limited availability of components continue to increase, making these parts more difficult to locate.

VIAVI Solutions, a supplier to the U.S. Military, conforms to the National Defense Authorization Act, Section 818, Detection and Avoidance of Counterfeit Electronics Parts. This Act requires that VIAVI prove the origin of all components and that the components used are from proven suppliers. It also warrants not to use counterfeit electronic parts or suspect counterfeit electronic parts in any of our products.
